#### Location: Mary's Hall

To understand the Islamophobia driven by white American Evangelicals — namely, the perception of Muslims as a threat to the preservation of America as a Christian nation — we must first endeavor to understand how Christian Nationalism conflates American identity with religious identity.

#### Race, Islam, and Children's Books: the Chronicles of Great Women Amal Alexander Location: Priscilla

Whether it's building the first university in the world more than 1,100 years ago where Muslims, Jews and Christians studied together side by side; the first queen in Arabia who ruled more than 70 years in Yemen; or the Nigerian warrior queen who united her tribes and ruled for over 30 years —author Amal Alexander aims to bring to light the deeds and actions of many influential women who have fallen into anonymity for much of the world.

#### Navigating Injustice: A Closer Look at Race, Faith, and Mental Health Nabil Tueme

This seminar presents findings from Springtide Research Institute's 2022 report, "Navigating Injustice," regarding what young Black, Indigenous, People of Color (BIPOC) are doing to find peace amid a generational mental health crisis amplified by historical trauma, discrimination, and other race-based forms of exclusion — helping faith leaders to address complex topics like mental health, racial identity, and racial injustice from a sociological perspective.

Faith, Culture, and Formation: The Impact of Interfaith Formation 1st & 2nd Year Students Transitioning into Higher Education on **HBCU Campuses** Kai El-Amin Location: Deborah

With the rise of secularism, far more students on Historically Black college and university (HBCU) campuses are self-identifying as "none" than in years past. While some religious factors have a positive impact on college success, other religious commitments undermine student success. (Darnell and Sherkat 1997). The aim of this pilot course is to determine if a local, Interfaith Immersion experience will have a positive impact on transitioning in 1st and 2nd year students in Higher Education on HBCU campuses.

#### African and African American Challenge to Slave Religions $\rightarrow \rightarrow$ **A'Jamal Byndon** Location: Ruth

Some African languages do not have a name for religion since their beliefs or philosophy are seen as integrated within their worldview. This session outlines the theories and philosophies of the African belief system before the advent of Christianity and Islam's inception on the continent.

The village of Boys Town was one of the first integrated communities in America where children of all races and religions lived together, attended school, played, and worshiped. Denounced by the KKK and other hate groups, visionary founder Father Edward J. Flanagan never wavered from his belief that all men and women were equal and deserved to be treated as such.

#### The Role of Interfaith Collaboration to Heal Our Nation's Divides Rebecca Shrestha and Liz Easton Location: Mary's Hall

Despite rising polarization, research shows that Americans believe someone with another opinion or belief system dislikes them 2x more than they actually do and 86% of Americans think we can improve our trust in one another (Beyond Conflict, 2020). Share Our America is a new initiative to rebuild our trust in one another through in-person gatherings of diverse groups: shared meals, local activities, and facilitated conversations about differences.

# Soul Doctors: The Role of Hospital Chaplains in Restoring Faith Nasreen Quadri

#### Location: Rahab

This case study examined an ACPE-certified CPE residency program that invited participation of Somali Muslim residents to address the chaplaincy representation gap (the vast majority of chaplains come from Christian backgrounds). How might this micromodel for building on community talents be expanded to provide culturally inclusive health care spaces in other local communities?

Mi Vida Espiritual: Elevating the Voice of 1.5 and 2nd Generation Latinos in Theological Studies

#### **Roger Garcia**

#### Location: Deborah

Despite a realization among religious leadership that the substantially increasing Latino population in America needs to be catered to for religious, spiritual, and ministerial outreach, support, and involvement, very little scholarship exists on the religious affiliation of the 1.5- and 2nd-generation Latino from Gen Z to Gen X. This study showcases modern data on what the religious affiliation trends are of this demographic and elevates their voices as it relates to their own desires for spiritual care, growth, and support.

#### Improving Interfaith Conversations with Evolutionary, Intergroup Psychology Leah Cech and Amanda Irions Location: Ruth

Traditional promotion of interfaith engagement has often failed to account for how some evolved psychological mechanisms facilitate and inhibit conversations among people with different social identities. This facilitated conversation will present some foundational concepts in intergroup communication and evolutionary psychology and explain how to use these concepts to frame interfaith dialogues for more successful outcomes.

#### Motivational Coaching for Muslim Young Adults Hamza Haqqi and Abdullah Najjar Location: Bathsheba

American Muslim Institute's (AMI's) work has pushed the practice of motivational coaching for young Muslim adolescents via psychological, mental, and spiritual activities. This presentation breaks down the success of these methods to foster holistic development among AMI student participants in preparation for their continued transition into adulthood.

#### >>> The Doctrine of Discovery and Religious Freedom Jeremy Fricke, Tri-Faith Initiative Staff Location: Tamar

The Papal Bull "Inter Caetera," issued by Pope Alexander VI in 1493, stated that any land not inhabited by Christians was available to be "discovered," claimed, and exploited by Christian rulers. This presentation explores how its legacy relates to the Protestant roots of America, Secularism and religious freedom as expressed in the U.S. Constitution, national narratives of Divine Providence, and the Christian Nationalism movements we see today.

#### >>> Countering Islamophobia, Antisemitism, Anti-Black Racism and Other Forms of Bigotry Against Racialized Groups

#### Zachary Markwith Location: Chapel Please note, this speaker will be appearing remotely

The workshop will demonstrate how to host an interethnic/intercultural panel on "Countering Islamophobia, Antisemitism, Anti-Black Racism, and Other Forms of Bigotry Against Racialized Groups." An abbreviated version of Islamic Networks Group's standard panel will be presented, and participants will then be engaged in dialogue and discussion both on the topics tackled by the panel and on the value of these presentations as part of a strategy to counter various forms of racism and bigotry in educational settings.

#### Redlining Policy, Real Estate and Race Terri Crawford Location: Priscilla

Though redlining was a deliberate disinvestment practice banned by the Fair Housing Act of 1968, decades of disinvestment have contributed to long-lasting effects for residents of formerly redlined communities in North and Northeast Omaha. The project provides a framework for understanding how contemporary racial

# disparities and the practice of redlining channeled into collaborations with real estate professionals and reshaped the private real estate structure.

Yanira earned a Bachelor of Science in Journalism and Public Relations and a Bachelor of Arts in Latino Latin American Studies from the University of Nebraska at Omaha (UNO). Recently Yanira also completed her Master of Arts in Integrated Media Communications at the University of Nebraska Lincoln (UNL)

Yanira is a proud wife and mother of two little girls. She is currently working at First National Bank of Omaha (FNBO) in marketing operations. She enjoys giving back to her community by volunteering as a board member for Habitat for Humanity Friends board, as a publications board member for UNO's student-run newspaper, The Gateway, and as an advisory member for her church One Hope in South Omaha.

#### Scott Littky

Scott Littky is the Executive Director of the Institute for Holocaust Education located in Omaha, NE. He has been with the Institute for Holocaust Education since the summer of 2018 and is very proud of the work he and his staff are doing.

The Institute for Holocaust Education provides educational resources, workshops, survivor testimony, and integrated arts programming to students, educators, and the public. The IHE provides support to Holocaust survivors in our community. Our goal is to ensure that the tragedy and history of the Holocaust are remembered, that appropriate, fact-based instruction and materials are available to students, educators, and the public to enable them to learn the lessons of the Holocaust and that, as a result, we inspire our community to create a more just and equitable society.

#### Peter Szto

Dr. Szto is Professor of Social Work at the Grace Abbott School of Social Work, University of Nebraska at Omaha. Before teaching he worked for 12 years in various inpatient and community mental health settings in Michigan and Philadelphia. His current research focuses on visualizing social welfare with projects in China, Singapore, and also mental health stigma and spirituality. Since 1996, he has taken 120 social work students on travel courses to China. Szto has earned degrees from Calvin University, Michigan State University, Westminster Theological Seminary, and the University of Pennsylvania. Dr. Szto was born and raised in New York City to Chinese

Taylor Keen is a full-time instructor in the Heider College of Business Administration in Strategy and Entrepreneurship at Creighton University. Keen holds a bachelor's degree from Dartmouth College as well as a Master of Business Administration and Master of Public Administration from Harvard University, where he served as a



Fellow in the Harvard Project on American Indian Economic Development. Taylor is the author of the forthcoming book from Inner Traditions Press "Rediscovering Turtle Island: A First Peoples' Account of the Sacred Geography of America".

A Cherokee Nation citizen, Keen carries the name "Bison Mane" of the Earthen Bison Clan of the Omaha Tribe, The People Who Move Against the Current. Taylor Keen is the Founder of Sacred Seed a NFP to educate and celebrate Indigenous Agricultural Lifeways. Keen serves as a member of the advisory board for the Plains Indian Museum at the Buffalo Bill Center of the West, the Joslyn Museum Plains Indian Collection, the Durham Museum, as well as the primary advisor for the Omaha Children's Museum, "A Generation of Hope", an Indigenous Peoples Children's Exhibit.

#### Justin Payne

Justin Payne (Music) is a classically-trained tenor, composer, and playwright from Omaha, Nebraska. In addition to collaborating with Dani Cleveland on Heaven Come Home and Little Brown Boy, Justin composed music for The Draft with playwright Lisa Harrison. One of Justin's newest creations is Belle Terre the Musical, a whimsical story that sends an adolescent young woman on a journey to self-discovery with music inspired by the New Orleans brass band style. Justin previously sang as the tenor soloist for Handel's Messiah with the Voices of Omaha, in addition to singing on stages in Germany, Austria, Italy, and China. He holds a Bachelor of Music from the University of Nebraska Omaha and a Master of Music from Michigan State University.

#### **Ferial Pearson**

Dr. Pearson is a mother, activist, author, educator, speaker, poet, comedienne, cook, and citizen of the world. As a Kenyan Indian Muslim immigrant queer disabled woman of color, she is passionate about Diversity, Equity, Inclusion, Accessibility, and Kindness.
